## <u>16.03.01</u> Apologies for Absence and Disclosure of Pecuniary Interests

He was also concerned that the play area entrance was not helping the problem and that the proposed expansion of the school would lead to increased traffic problems.

Cllr. Wilson stated that discussions were taking place with Highways regarding the area around the play zone and that the school was working very hard to keep traffic flowing at drop-off and pick-up times.
