1. Report on the meeting with Ian Lovatt Highways solely for the purpose of establishing the viability of putting a Solar Powered Activated Sign on Lower Lane.

The purpose was twofold

a. To protect All Pedestrians using Lower lane.

b. To Slow Down Traffic approaching the School, to make it Safer particularly at Opening and Closing times when traffic is heavy.

Two suitable sites were identified and I have spoken to both landowners.One landowner has refused . The other landowner has been spoken to several times on the phone and we are urgently trying to arrange a meeting which is proving difficult because of work commitments.This will be resolved as soon as possible. Until we have had this discussion no further progress can be made.I will advise urgently on progress. A letter to the owner will be sent to confirm all points discussed.

2. Discussion on All Alternatives to a V A S sign.

The following options were discussed .

- a. Speed Cushions and Speed Humps.
- b. Road Narrowing.
- c. Raised Coloured Road Surface

These alternatives were discussed at length. Anything associated with Road

Narrowing had to be dismissed as Lower Lane is too Narrow anyway.

Speed cushion and Humps were ruled out as Highways are stopping using this

method .

Raised Coloured Road surface was deemed too expensive and would not in the

opinion of the committee help the traffic congestion problems at school opening

and closing times nor would be inkeeping with a Rural village.

3. The committee decided that if possible a V.A.S. Sign would be the most viable

and affordable option. If this came about residents of the village would be advised prior to installation. This recommendation to be passed to the Parish Council . Phil Alcroft to be advised at the appropriate time for inclusion in the Newsletter.
